ORDINANCE NO. 2036

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF
HEMET, CALIFORNIA, AMENDING THE HEMET
MUNICIPAL CODE TO REVISE REGULATIONS FOR
STOREFRONT COMMERCIAL CANNABIS BUSINESSES

THE CITY COUNCIL OF THE CITY OF HEMET DOES HEREBY ORDAIN AS
FOLLOWS:

SECTION 1: MUNICIPAL CODE AMENDMENT.

**(B) Section 18-525(b) of the Hemet Municipal Code shall be amended to read
as follows:**

(b) Retail businesses must be located in the C-2 (Commercial General) zone of the city and must meet all of the requirements for development in these zones. The retail business must also (1) be no closer than 600 feet from any other cannabis retail business and (2) be no closer than 500 feet to any of the uses described in subsection (a)(3) above. For the purposes of this subsection (b) distances shall be measured along the shortest path of travel between the entrance to the retail business and the structure containing the use described in subsections (b)(1) and (b)(2) above.

SECTION 2: SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section,

1 subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the
2 fact that any one or more sections, subsections, subdivisions, sentences, clauses,
3 phrases, or portions thereof be declared invalid or unconstitutional.


5 **SECTION 3: CEQA.** The City Council hereby determines that it can be seen with
6 certainty that there is no possibility that this Ordinance will have a significant effect on
7 the environment, and therefore, this Ordinance is exempt from the provisions of CEQA.

8 **SECTION 4: EFFECTIVE DATE.** This Ordinance shall take effect thirty (30) days from
9 its passage by the City Council of the City of Hemet.

11 **SECTION 5: PUBLICATION.** The City Clerk is authorized and directed to cause this
12 Ordinance to be published in the manner required by law.


