The City of Hemet, Administrative Services Department is the lead agency responsible for the development of the Consolidated Plan with information provided by other departments including City Manager, City Council, the Public Works-Engineering Division, the Community Development Department which includes the Planning Division.

In addition, the City collaborates with the following County of Riverside agencies:

The Housing Authority of the County of Riverside provides supplemental rental assistance to income-eligible persons seeking affordable housing. One of the primary responsibilities of the Housing Authority is the administration of the HUD Section 8 Rental Assistance Program. The Housing Authority owns and operates affordable housing projects throughout the county and cooperates with local jurisdictions in the rehabilitation and upgrade of multi-family housing units. The Housing Authority also administers or participates in several supportive service programs offered within Hemet.

The County of Riverside Continuum of Care (CoC) is comprised of representatives from public and private agencies, local governments, and community residents including homeless and formerly homeless individuals that are committed to facilitating a well-coordinated Continuum of Care planning process throughout the County. The mission of the Coalition is to assess the need for homeless and affordable housing services and to develop and recommend a continuum of care plan for the County on behalf of at risk and homeless individuals and families.

The Housing, Homeless Prevention, and Workforce Solutions (HHPWS) is the umbrella anti-poverty agency for the County of Riverside and lead agency of the CoC. The goal is self-sufficiency accompanied by moving poor families out of poverty. HHPWS interacts with people on many levels, thereby impacting their daily lives through child care, education, employment training, health and human services, homelessness, and housing.

The Riverside County Continuum of Care (CoC) is designed to promote community-wide planning and strategic use of resources to: address homelessness; improve coordination and integration with mainstream resources and other programs targeted to people experiencing homelessness; improve data collection and performance measurement; and allow each community to design programs to the particular strengths and challenges within the community. The goal of the Riverside County Housing, Homeless Prevention, and Workforce Services (HHPWS) which serves as the lead agency of the CoC, is to coordinate homeless efforts and meet the varied needs of the County's homeless residents as well as establishing policies and procedures for oversight. The CoC is comprised of a wide-range of community stakeholders that include businesses, community service groups, faith-based agencies, local government, private foundations and anyone with a desire to support the goals of the CoC.

The City of Hemet’s Citizen Participation Plan both provide for and encourage public participation. Introduction

The City of Hemet's SP-35 Anticipated Resources section outlines the expected financial resources available to address the community's housing and development needs over the Consolidated Plan period. These resources primarily include federal funding from the U.S. Department of Housing and Urban Development (HUD), supplemented by state and local funds, as well as private investments.

The primary federal resource is the Community Development Block Grant (CDBG), an annual allocation from HUD designed to support a wide range of community development activities, including affordable housing, anti-poverty programs, and infrastructure development.

To maximize the impact of these federal funds, the City actively seeks to leverage additional resources, including state and local funds, private investments, and program income. State and local funds consist of grants and allocations from state programs and local government budgets that align with the City's housing and community development objectives. Private investments involve partnerships with private developers, financial institutions, and non-profit organizations to attract capital for housing and economic development projects. Program income refers to revenue generated from previous HUD-funded activities, such as loan repayments, which can be reinvested into new projects.

The anticipated resources will be strategically allocated to address the priority needs identified in the Consolidated Plan, which include developing and preserving affordable rental and ownership housing options for low- and moderate-income households, providing assistance and services to prevent homelessness and support those currently experiencing homelessness, and investing in public facilities, infrastructure improvements, and economic development initiatives to enhance the quality of life in Hemet's neighborhoods. By effectively utilizing and coordinating these resources, the City of Hemet aims to make significant progress toward its goals of providing safe, affordable housing and fostering a vibrant, sustainable community.

While the Community Development Block Grant (CDBG) program does not mandate a matching requirement, the City of Hemet is committed to maximizing the impact of these federal funds by leveraging a array of additional resources. This strategic approach involves integrating federal funds with state and local resources, as well as private investments, to comprehensively address the community's housing and development needs.

Historically, Hemet has successfully combined CDBG allocations with various funding sources to enhance project outcomes. For instance, the city has utilized funds from the State of California Housing and Community Development HOME program, Mortgage Credit Certificates (MCC) administered by Riverside County, and local utility conservation and energy efficiency programs offered by Southern California Edison and Southern California Gas. These collaborations have been instrumental in advancing affordable housing projects, improving community facilities, upgrading infrastructure, and supporting public service programs.

Additionally, the city actively pursues other governmental funding opportunities, such as regional, state, and federal infrastructure grants. By identifying, monitoring, and applying for these funds, Hemet aims to supplement its CDBG resources, thereby facilitating more comprehensive and impactful community development initiatives.

The City of Hemet, in collaboration with the Housing Authority of Riverside County, owns various parcels of land and properties within its jurisdiction. Description of the geographic areas of the entitlement (including areas of low-income and minority concentration) where assistance will be directed

The City of Hemet will direct the majority of its Community Development Block Grant (CDBG) funding to areas with the highest concentration of low- and moderate-income (LMI) residents, as defined by HUD’s Low/Moderate Income Area (LMA) data. These neighborhoods experience higher rates of poverty, housing instability, and aging infrastructure, making them a priority for investment in housing rehabilitation, public facility improvements, infrastructure enhancements, and public services.

Based on the City’s 2025-2029 Consolidated Plan Needs Assessment, these areas also have a disproportionately high percentage of minority populations, particularly Hispanic, Black/African American, and senior residents who are more vulnerable to housing cost burdens and economic instability. The City's funding strategy is designed to alleviate disparities, enhance neighborhood conditions, and expand economic opportunities for these communities.

Although a significant portion of funds will be concentrated in specific LMI neighborhoods, some funding will be allocated for citywide programs that benefit LMI individuals regardless of their location. These programs include homelessness prevention, fair housing services, small business assistance, and programs for seniors and youth. This approach ensures that while geographically targeted investments improve conditions in the most underserved neighborhoods, critical social services remain accessible to eligible residents citywide.

Rationale for the priorities for allocating investments geographically

The City of Hemet’s allocation of Community Development Block Grant (CDBG) funds is driven by a strategic analysis of demographic, economic, and housing data, combined with community input and HUD-designated Low- and Moderate-Income (LMI) Area (LMA) mapping. The primary objective is to direct resources where they are most needed while ensuring citywide access to critical services for low- and moderate-income individuals and families. A majority—approximately 70%—of CDBG funds are targeted to census tracts with high concentrations of LMI households. Many of these residents face severe rent burdens, spending over 30–50% of their income on housing. Investments in these areas aim to enhance housing stability, improve infrastructure, and expand economic opportunities. Older neighborhoods, particularly those with homes built before 1980, face significant housing quality issues such as lead-based paint, poor insulation, and accessibility limitations. Housing rehabilitation programs will focus on assisting low-income homeowners with critical repairs, improving health and safety, and

reducing displacement. Infrastructure gaps are also a major concern. Several LMI neighborhoods lack basic infrastructure like sidewalks, street lighting, drainage, and ADA-compliant public facilities. CDBG funds will support sidewalk repairs, ADA curb ramps, stormwater improvements, and upgrades to community centers and parks. Economic disparities persist, with high unemployment and limited access to small business capital in LMI areas. CDBG investments will support job training, small business assistance, and commercial revitalization to stimulate local economic development. While most CDBG funding is geographically targeted, 30% supports citywide programs—such as fair housing services, senior support, youth programs, and homelessness outreach—ensuring access across Hemet. This targeted strategy allows Hemet to address concentrated poverty and housing instability while also maintaining essential services for vulnerable residents citywide, advancing stability and quality of life for LMI communities.

Discussion

The City of Hemet’s Community Development Block Grant (CDBG) geographic investment strategy is informed by HUD-defined Low- and Moderate-Income (LMI) Area data, a citywide needs assessment, and community engagement. This approach ensures funding is directed to neighborhoods with the highest levels of need while maintaining citywide access to essential services for low- and moderate-income residents.

Affordable Housing

AP-55 Affordable Housing – 91.220(g)

Introduction

The City of Hemet is committed to expanding and preserving affordable housing for low- and moderate-income households by investing in targeted rehabilitation, rental assistance, and supportive housing programs. Through the use of Community Development Block Grant (CDBG) funding and other resources, the City aims to address housing instability, reduce the risk of homelessness, and improve living conditions for vulnerable residents—particularly seniors, disabled individuals, and low-income families. For the 2026–2027 program year, Hemet’s affordable housing strategy emphasizes three core priorities: preventing homelessness, preserving and rehabilitating affordable housing, and supporting special-needs populations. A key goal is to maintain existing affordable housing stock while ensuring safe, accessible, and sustainable homes for both renters and homeowners at risk of displacement or living in substandard conditions.

Discussion

The City of Hemet’s 2026–2027 affordable housing strategy focuses on preserving existing housing, providing rental assistance, and preventing homelessness. Rather than developing new units, the City is prioritizing immediate needs based on funding constraints, aging housing stock, and the housing challenges faced by low- and moderate-income households—especially seniors, people with disabilities, and those experiencing housing instability. Many Hemet renters spend over 30–50% of their income on housing, making them highly vulnerable to eviction and homelessness. Rental assistance programs will play a central role in stabilizing these households. Meanwhile, much of Hemet’s housing stock predates

1980 and requires significant rehabilitation. Through the City’s CDBG-funded Housing Rehabilitation Program, low-income homeowners will receive financial support for essential repairs and ADA modifications to ensure homes remain safe and habitable. The cost of land, materials, and development fees continues to limit new affordable housing construction within this program year. Although no new units will be completed in 2026–2027, the City is actively pursuing future funding opportunities—including LIHTC, PLHA, and partnerships with private developers—to support long-term affordable housing production. Special-needs populations remain a top priority. Many seniors and disabled individuals on fixed incomes face accessibility challenges in older homes. The City will prioritize home modifications such as ramps, grab bars, and accessible bathrooms to promote independent living.

AP-60 Public Housing – 91.220(h)

Introduction

The City of Hemet does not operate its own public housing authority (PHA) but works closely with the Housing Authority of the County of Riverside (HACR) to support public housing initiatives and rental assistance programs for low-income residents. HACR administers the Section 8 Housing Choice Voucher (HCV) Program and public housing units throughout Riverside County, including Hemet. The City coordinates with HACR to address affordable housing needs and improve access to rental assistance for eligible households.

Public housing plays a critical role in providing stable, affordable homes for extremely low- and very low-income households, including seniors, disabled individuals, and families with children. The demand for rental subsidies and public housing units continues to exceed available resources, resulting in long waitlists for Section 8 vouchers and subsidized housing options. The City of Hemet remains committed to supporting initiatives that expand affordable rental housing opportunities and improve the living conditions of public housing residents.

Hemet's approach to public housing support focuses on collaboration with HACR, advocacy for additional rental assistance funding, and participation in regional housing initiatives. The City also works with nonprofit housing providers to develop and preserve affordable housing, ensuring that low-income residents have access to safe and stable housing.

Actions planned during the next year to address the needs to public housing

The City of Hemet will continue its collaboration with the Housing Authority of the County of Riverside (HACR) to support low-income households who rely on public housing and rental assistance programs. Although the City does not own or manage public housing, it plays a vital role in advocacy, coordination, and support for residents utilizing Section 8 Housing Choice Vouchers (HCV) and other HACR-administered programs. Outreach and Access To address public housing needs in the upcoming year, the City will focus on increasing awareness of and access to rental assistance for eligible residents. Many households in Hemet face barriers such as long waitlists and limited knowledge of how to apply for assistance. In response, the City will provide outreach, referrals, and application support to help residents navigate HACR's programs.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

The City of Hemet, in collaboration with the Housing Authority of the County of Riverside (HACR), is committed to strengthening resident engagement in public housing management and expanding opportunities for low-income households to achieve homeownership. Recognizing that tenant involvement and financial empowerment are key to housing stability, the City will implement supportive strategies to help residents take a more active role in their housing journey. To promote greater resident participation, the City will support HACR's Resident Advisory Board (RAB) meetings, where

tenants provide feedback on housing policies, maintenance concerns, and community services. Hemet will assist by publicizing these meetings, distributing informational materials, and collaborating with local service providers to increase tenant engagement. By fostering open communication between residents and housing officials, Hemet aims to ensure that public housing decisions are informed by those directly impacted. In addition, the City will help promote homeownership opportunities for Section 8 Housing Choice Voucher (HCV) recipients through HACR's Homeownership Program. This initiative enables eligible participants to use their housing vouchers for mortgage payments, helping low-income families build long-term stability. The City will partner with financial institutions, housing counselors, and nonprofits to offer homebuyer education , credit repair , and down payment assistance to prospective homeowners.

AP-65 Homeless and Other Special Needs Activities – 91.220(i)

Introduction

The City of Hemet is committed to addressing homelessness and the housing needs of special-needs populations, including seniors, disabled individuals, victims of domestic violence, and those at risk of becoming homeless. Through collaboration with the Housing Authority of the County of Riverside (HACR), local nonprofit service providers, and regional agencies, the City works to expand access to emergency shelter, rapid rehousing, permanent supportive housing, and homelessness prevention programs.

Homelessness remains a critical challenge in Hemet, with a rising number of individuals and families facing housing instability due to economic hardship, mental health challenges, and lack of affordable housing options. The City utilizes Community Development Block Grant (CDBG) funds and other available resources to support street outreach, case management, rental assistance, and supportive services designed to help individuals transition from homelessness to stable housing.

The City also prioritizes the needs of special-needs populations, including the elderly, disabled persons, and individuals with chronic health conditions, by funding affordable housing rehabilitation programs, accessibility modifications, and supportive housing services. The goal is to ensure that vulnerable residents have access to safe, stable, and affordable housing while receiving the necessary services to maintain long-term housing stability.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The City of Hemet will expand street outreach efforts to engage unsheltered individuals and families in areas where they are most frequently found, including parks, public spaces, and encampments. The City will work with the Riverside County CoC, local homeless service providers, and law enforcement agencies to deploy trained outreach teams that conduct needs assessments, provide crisis intervention, and connect individuals with emergency shelter and support services.

A key outreach goal is to increase the use of the Coordinated Entry System (CES) and the Homeless Management Information System (HMIS), which help streamline services and ensure that homeless individuals receive personalized assistance based on their specific needs. Outreach teams will assist individuals with obtaining identification, signing up for benefits such as Supplemental Security Income (SSI), and accessing healthcare and behavioral health services.

The City will also support mobile outreach efforts, including mental health response teams and substance abuse counselors, to address the underlying issues that contribute to chronic homelessness. In coordination with faith-based organizations and local nonprofits, the City will provide essential supplies such as food, hygiene kits, and clothing, ensuring that individuals experiencing homelessness receive both immediate relief and long-term solutions.

Addressing the emergency shelter and transitional housing needs of homeless persons

the City will collaborate with local emergency shelters and transitional housing providers to expand services that help people transition from homelessness to stable, permanent housing. CDBG and other local resources will be directed toward increasing shelter capacity, ensuring 24-hour accessibility, and enhancing wraparound services—including mental and physical healthcare, case management, and life skills training. These efforts will focus on vulnerable populations such as survivors of domestic violence, unaccompanied youth, and families with children by working closely with shelters that specialize in serving these groups. To support the transition from homelessness, Hemet will continue to invest in rapid rehousing and transitional housing programs. These initiatives provide rental assistance, employment support, and financial literacy training to promote long-term self-sufficiency. The aim is to reduce shelter stays and move individuals into permanent housing as efficiently as possible.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The City of Hemet, in collaboration with the Riverside County Continuum of Care (CoC) and a network of nonprofit and public agencies, is committed to supporting homeless individuals and families—particularly those who are chronically homeless, families with children, veterans, and unaccompanied youth—in transitioning to permanent housing and achieving long-term stability. This is accomplished through a comprehensive and coordinated approach that integrates housing access, supportive services, and system-wide data tracking to reduce the duration and recurrence of homelessness.

A core component of this strategy is the Housing First model, which prioritizes immediate access to permanent housing without preconditions such as sobriety or income. Once housed, individuals and families receive wraparound services tailored to their needs, including case management, employment support, behavioral health services, and access to benefits. For chronically homeless individuals, Permanent Supportive Housing (PSH) programs provide long-term housing subsidies combined with intensive case management to promote stability and independence. Families and individuals with fewer barriers are served through Rapid Rehousing (RRH) programs, which offer short- to medium-term rental assistance and supportive services aimed at helping them secure and maintain housing quickly.

The Coordinated Entry System (CES), known locally as HomeConnect, serves as the primary access point for all housing interventions in the region. Through CES, households are assessed for vulnerability and matched to the most appropriate housing resource available. This system ensures that those with the highest needs—including veterans, families with children, and youth—are prioritized for housing placements.

Efforts to shorten the duration of homelessness focus on reducing the time between outreach, assessment, and housing placement. Outreach teams engage individuals living in encampments or unsheltered locations, working quickly to connect them to available resources. Once housed, program participants receive continued case management to help stabilize their lives and prevent future episodes of homelessness.

To prevent returns to homelessness, the City and CoC partners invest in post-housing stabilization services such as rental assistance extensions, employment training, and mental health care. These supports are critical during the transition to independent living and help ensure long-term housing retention.

Additionally, targeted prevention programs address the needs of individuals at imminent risk of homelessness. These include legal assistance for tenants facing eviction, one-time rental or utility assistance, and diversion services aimed at helping individuals identify safe alternatives to shelter entry. Special focus is given to individuals exiting systems of care such as hospitals, foster care, and correctional facilities to ensure they are not discharged into homelessness.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

The City of Hemet, in coordination with Riverside County and the regional Continuum of Care (CoC), employs a multi-layered strategy to help low-income and extremely low-income individuals and families avoid becoming homeless. This includes early intervention, cross-system coordination, targeted financial assistance, and proactive discharge planning for individuals exiting publicly funded institutions and systems of care.

A key prevention tool is the Homelessness Prevention and Diversion Program, which is implemented through County-administered Emergency Solutions Grant (ESG), HHAP, and other state and federal resources. This program provides short-term financial assistance—such as rent arrears, utility payments, or relocation support—to households facing eviction or imminent homelessness. Priority is given to extremely low-income households and those with multiple barriers to housing stability. Legal services and mediation programs also help tenants avoid eviction through advocacy and negotiated resolutions with landlords.

The Riverside County Department of Public Social Services (DPSS) and Department of Housing and Workforce Solutions (HWS) play a central role in identifying at-risk households and referring them to appropriate resources, including housing stabilization programs, Section 8 vouchers, and employment

supports. The Coordinated Entry System (HomeConnect) integrates prevention screening into its intake process, allowing for early identification of at-risk individuals and rapid connection to services before homelessness occurs.

Special attention is given to individuals exiting publicly funded systems of care. The County has implemented a formal Discharge Planning Policy, which establishes protocols for collaboration between hospitals, behavioral health providers, the child welfare system, correctional institutions, and CoC service providers. This policy ensures that individuals are not released from institutions directly into homelessness, but are instead connected to housing resources, case management, and follow-up support. For example:

- Youth aging out of foster care are connected to transitional housing and extended services through programs like THP-Plus.
- Individuals leaving inpatient behavioral health facilities or substance use treatment programs are referred to supportive housing or recovery housing options.
- Persons exiting jails or reentry programs are linked to rapid rehousing, employment assistance, and peer navigation programs.

For households receiving ongoing assistance from public or private agencies—such as those accessing CalWORKs, Medi-Cal, or county behavioral health programs—the County integrates service navigation and housing counseling to address housing instability as part of the broader care plan. Nonprofit organizations in Hemet, including Valley Restart Shelter, City Net, and faith-based agencies, also play a frontline role in delivering outreach, rental assistance, and family stabilization services.

In summary, Hemet and its regional partners employ a collaborative, systems-based approach to homelessness prevention—anchored in financial stabilization, service coordination, and institutional discharge planning. These efforts ensure that the most vulnerable residents, including those exiting public systems and receiving public services, are supported in maintaining housing and avoiding the trauma of homelessness.

Discussion

The City of Hemet remains committed to reducing homelessness through a comprehensive, coordinated approach that includes street outreach, emergency shelter, transitional housing, and permanent housing solutions. For the 2026–2027 program year, the City will prioritize increasing housing stability, expanding access to emergency services, and strengthening partnerships with the Riverside County Continuum of Care (CoC), nonprofits, and regional agencies. Homelessness in Hemet continues to grow due to rising rental costs, limited affordable housing, mental health challenges, and economic instability. The City’s CDBG-funded programs support vulnerable groups including unsheltered individuals, at-risk households, domestic violence survivors, veterans, seniors, and persons with disabilities.

AP-75 Barriers to affordable housing – 91.220(j)

Introduction:

The City of Hemet recognizes that several barriers to affordable housing development and access exist, limiting the ability of low- and moderate-income households to secure stable, affordable housing. These barriers include high housing costs, limited developable land, regulatory constraints, infrastructure deficiencies, and economic challenges that impact housing affordability and production. Additionally, factors such as zoning restrictions, development fees, and community opposition can further delay or prevent the construction of affordable housing units.

The 2026-2027 program year will focus on identifying and addressing these barriers through policy changes, financial incentives, and strategic partnerships with housing developers and nonprofit organizations. The City will work to streamline development processes, advocate for funding opportunities, and implement strategies that encourage the construction and preservation of affordable housing.

The following section outlines the primary barriers to affordable housing in Hemet and the actions the City will take to mitigate these challenges during the upcoming year.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The City of Hemet is dedicated to removing regulatory and financial barriers that limit the development and availability of affordable housing. In the 2025–2026 program year, the City will implement targeted policy reforms and incentives to support affordable housing creation and preservation. Streamlining Land Use and Zoning: Hemet will revise zoning ordinances to allow higher-density residential development, especially near transit corridors and commercial zones. Reduced parking requirements and flexible design standards will encourage mixed-use and affordable projects. The City will also promote Accessory Dwelling Units (ADUs) by simplifying permits and waiving impact fees for ADUs offered at affordable rents.

To lower development costs, the City will assess opportunities to reduce or defer impact fees for affordable projects. A fast-track permitting process will be introduced for developments that include low-income housing, especially those led by nonprofit developers.

The City will offer density bonuses, parking reductions, and flexible design rules to incentivize affordable housing. It will also support developers in securing Low-Income Housing Tax Credits (LIHTC) and encourage Public-Private Partnerships to increase funding for affordable units.

Discussion:

The City of Hemet acknowledges that affordable housing development is constrained by several barriers, including restrictive zoning, high development costs, infrastructure limitations, and limited land availability. These factors not only hinder new housing construction but also exacerbate housing cost burdens for low- and moderate-income residents. To address these challenges, the City is actively pursuing zoning reforms, development incentives, and strategic partnerships to support affordable housing development and preservation. A major barrier is zoning regulations that restrict higher-density and multifamily developments in many areas of the city. To address this, Hemet is reviewing and amending zoning ordinances to allow for increased density, mixed-use developments, and Accessory Dwelling Units (ADUs) in more neighborhoods. These changes aim to expand housing supply and affordability through infill development and smaller, lower-cost housing options. Development fees and permitting timelines also create financial burdens for affordable housing developers. The City is working to reduce or defer impact fees for affordable projects, fast-track permitting for developments with low-income units, and offer financial incentives such as density bonuses and tax abatements. These efforts aim to lower upfront costs and attract both nonprofit and private developers. Infrastructure limitations present another challenge, especially in areas lacking adequate sewer, utility, and road capacity. The City plans to leverage Community Development Block Grant (CDBG) and other federal and state funding sources to invest in infrastructure improvements that enable housing development in underserved areas. Additionally, the City is partnering with nonprofits, community development corporations, and private investors to pursue funding through programs like the Low-Income Housing Tax Credit (LIHTC). Hemet is also enhancing tenant protections by supporting fair housing education, legal assistance, and rental assistance programs. Together, these initiatives reflect Hemet's commitment to breaking down housing barriers, promoting affordability, and ensuring access to safe and stable housing for all residents.

AP-85 Other Actions – 91.220(k)

Introduction:

The goal of the City of Hemet, with funding from CDBG, is to increase self-sufficiency and economic opportunity for lower-income residents and individuals with special needs so that they can achieve a reasonable standard of living.

The diverse population of Hemet is accompanied by divergent needs to help attain personal, educational, employment, recreational, housing, and other goals. The City is struggling to balance limitations of available resources and the need to address some very critical issues including maintaining affordable housing, homelessness, aging infrastructure and community facilities, inadequate services, and underemployment.

Actions planned to address obstacles to meeting underserved needs

The main obstacle to meeting underserved needs continues to be the availability of funding. The availability of both federal and state sources is a primary determination the ability of local jurisdictions to address identified needs. Federal and state funding of housing and community development programs continues to be reduced and future funding from traditional sources is debatable as lawmakers attempt to balance federal and state budgets. The City will continue to pursue all available sources of funding to address the needs of affordable housing and community development.

Actions planned to foster and maintain affordable housing

The City of Hemet will continue to support development of additional affordable ownership and rental units. Development of affordable housing requires substantial leverage of public funds, and multiple layers of funding are often required to address the subsidies required. The City will continue to pursue available local, State, and federal funding resources for this purpose. In addition, the City will continue efforts to implement strategies and strengthen partnerships with its partners to expand affordable housing.

Actions planned to reduce lead-based paint hazards

The Consumer Product Safety Commission banned the use of lead-based paint in housing in 1978. According to the National Safety Council, approximately 38 million US homes contain lead paint. Any housing built prior to 1979 is considered to be at risk of containing some amount of lead-based paint. In particular, housing units constructed prior to 1950 have been found to have some of the highest levels of lead-based paint.

Under the Residential Lead-Based Paint Hazard Reduction Act of 1992 - Title X, a lead-based paint (LBP) hazard is defined as "any condition that causes exposure to lead from lead-contaminated dust,

lead-contaminated soil, lead-contaminated paint that is deteriorated or present in accessible surfaces, friction surfaces, or impact surfaces that would result in adverse human health effects." The City of Hemet, Housing Authority of Riverside County, Riverside County Department of Public Health and the State of California Childhood Lead Poisoning Prevention Branch all have a role in addressing LBP hazards in Hemet.

The Childhood Lead Poisoning Prevention Program is a tool in the identification of lead hazards in the home, the Lead Hazard Reduction Compliance and Enforcement Program provides technical expertise in lead based paint management, the Lead Hazard Control Program requires the enforcement and prosecution of persons who refuse to abate lead hazards in housing occupied by low income families with children, the HEPA Vacuum Lending Program provides training and use of commercial grade HEPA vacuums to low income residents who want to do their own interim control, and the Public Health Department Childhood Lead Prevention Program provides outreach services to WIC, schools and communities.

Actions planned to reduce the number of poverty-level families

The City of Hemet will continue its efforts to reduce the number of families and individuals living in poverty. The City will focus primarily on supporting programs that raise household incomes and stabilize housing situations. The City will utilize CDBG to support the continuation and implementation of affordable housing that help homeless person's make the transition to permanent housing and independent living.

Hemet will use resources from state, federal and private sources to provide a number of community-based and direct services aimed directly or indirectly, at decreasing the poverty level. These programs include: job enrichment, development, and placement through education and economic development; food pantry programs, and programs designed to prevent and alleviate the devastating impact of domestic violence, which often plunge women and their children into poverty.

Actions planned to develop institutional structure

The identified strengths and gaps provide a basis for cooperative strategies to fill gaps in the housing and community development delivery system. Focus on the institutional structure involves a broad strategy of coordination, empowerment, and communication with public, private, and non-profit sectors. Gaps in services, identified through the needs assessment process will be CDBG funded when innovative supportive services are presented during the annual funding process. CDBG funding will also be used to offset program delivery costs as appropriate.

City of Hemet staff maintains working partnerships with the Riverside County Employment Development Department, local financial institutions, school districts, community businesses, public agencies, and private partners such as the Fair Housing Council of Riverside County and local nonprofits.

Actions planned to enhance coordination between public and private housing and social service agencies

The City will continue to enhance coordination between public and private housing and social service agencies through collaboration with various local nonprofit organizations, the Housing Authority of the County of Riverside, the County of Riverside Economic Development Agency and other agencies that partner with the City to revitalize low income communities utilizing CDBG, mortgage revenue bonds, CalHome, and mortgage credit certificates.

The City as a collaborative partner of the CoC continues to play an important role in both facilitating and directly bringing together disparate interests to develop new or strengthen existing institutional structures, and enhance coordination between housing and service agencies. There are a variety of services for special needs populations and persons experiencing homelessness; however, major gaps in the service delivery system exist, including: inadequate funding to provide the level of services needed; lack of coordination and communication among different agencies; and uneven geographic coverage of services, with some rural and remote communities being underserved.

Actions to overcome these obstacles will continue as part of the Annual Action Plan and Citizen Participation processes.

Discussion:

To better link services to the targeted population, City staff maintains relationships with local, state and federal agencies including, the County Department of Health and Human Services, California Department of Housing and Community Development, and the U.S. Department of Housing and Urban Development.
