**RE: Cultural Resources Technical Memorandum for the IS/MND for the Proposed Downtown Specific Plan for the City of Hemet, Riverside County**

Dear Ms. Bean

The purpose of this letter report is to provide the results of the Cultural Resources Study conducted by ECORP Consulting Inc. (ECORP) under contract with First Carbon Solutions (FCS) in support of the Downtown Hemet Specific Plan. The study was conducted within the limits of the City of Hemet's downtown Specific Plan planning boundary. For this project, ECORP analyzed and summarized cultural resources record search data provided to ECORP by FCS, reviewed and incorporated previous existing cultural studies specific to the Planning Area, reviewed and summarized available historic-period maps of the area, contacted the Hemet Heritage Foundation, conducted windshield surveys of the Planning Area, compiled the data to assess the archaeological and historic sensitivity of the Planning Area, created cultural resources overview and sensitivity maps, and prepared this technical memorandum to document the methods and results of the study.

### **LOCATION AND SETTING**

The Planning Area is located in the City of Hemet in Riverside County, California (see Figure 1 in Attachment A). The study area is located within an un-sectioned portion of the San Jacinto Viejo Land Grant, as depicted on the USGS 7.5' Hemet (1996) and the San Jacinto (1996) topographic quadrangle maps. The Planning Area is bordered by Oakland Avenue to the north, Acacia Avenue to the south, Gilbert Street to the west and Santa Fe Street to the east (see Figure 2 in Attachment A).

The Planning Area incorporates portions of the Downtown District of the City of Hemet. The Planning Area is generally characterized as heavily developed and contains a mix of residential, commercial and light industrial areas. A portion of the Planning Area is intersected by a spur of the California Southern Railroad, but the rail line is no longer operational today.

## LITERATURE REVIEW METHODS AND RESULTS

**Records Search Review.** ECORP acquired cultural resources record search data from FCS on January 3, 2016. The records search was conducted on September 28, 2016 by the Eastern Information Center (EIC) at the University of California Riverside in Riverside, California at the request of FCS. The EIC is the official repository of cultural resources reports and site records for Riverside, Inyo and Mono Counties. The records search was conducted in order to identify the locations and extents of previous surveys conducted within 1.0 mile of the Planning Area and to determine if there are known cultural resources within or near the Planning Area. In addition, the records search checked for resources listed on or determined eligible for listing on the National Register of Historic Places (NRHP) and/or the California Register of Historical Resources (CRHR) located within or near the Planning Area.

The records search identified 30 cultural resources studies that have been conducted between 1975 and 2006 within 1 mile of the Planning Area. Of the 30 cultural resources studies, one survey conducted by Carolyn Kyle in 2005 for a wireless telecommunication facility overlaps a portion of the Planning Area. This study did not identify any cultural resources. No other surveys have been conducted within the Planning Area.

The records search also identified a total of 77 cultural resources that have been previously recorded within and within 1 mile of the Planning Area. Of the 77 previously-recorded cultural resources, 29 are within the Planning Area. The majority of cultural resources identified are characterized as historic-age (i.e. over 50 years of age), built-environment structures. A historic-period district has been previously recorded south of Kimball between Gilbert Street to the west and Juanita Avenue to the east. This district was identified by Jim Warner of the Riverside County Historical Commission in 1982. Many of the previously-recorded cultural resources within the Planning Area were recorded in the early 1980s by the Riverside County Historical Commission, and consist primarily of vernacular style residences, barns, and commercial or industrial structures. Additional architectural styles represented in the Planning Area include Craftsman, Bungalow, Colonial Revival, Queen Anne, Tudor Revival, and Pueblo/Mediterranean/Spanish Revival.

No prehistoric resources have been recorded within the Planning Area or within a 1-mile radius.

The Historic Property Data File (HPDF) for the Hemet area was searched and revealed that there are 48 additional historic-period resources located within the Planning Area. There are no NRHP or CRHR eligible sites located within the Planning Area or within a 1-mile radius.

The results of the records search have been compiled and are presented in Table 1, Table 2a, and Table 2b in Attachment B.

**City of Hemet General Plan Cultural Resources Background Report Review.** In 2006 in support of the City of Hemet's General Plan, Applied Earthworks prepared a Cultural Resources Technical Background Report (Horne and McDougal 2006). As part

of this study, an ECORP Cultural Resource Specialist reviewed the 2006 Cultural Resources Technical Background Report. The report identified prehistoric resources present in the City of Hemet and the surrounding sphere of influence and the potential to encounter previously undiscovered subsurface archaeological deposits. None of the known prehistoric resources, however, are located within the current Planning Area. The report also identified eight historic-period neighborhoods (Horne and McDougal 2006). The neighborhoods identified include:

- The Park Hill Historical Neighborhood and Northeast Hemet
- The Northeast Central Hemet Historical Neighborhood
- The Northwest Central Historical Neighborhood
- The Central Hemet and Hemet Fairgrounds Historical Neighborhood
- The Fruitvale Historical Neighborhood
- The Southeast Central Hemet Historical Neighborhood
- The Southwest Central Hemet Historical Neighborhood
- The Hemet Downtown Neighborhood

Of the eight neighborhoods identified by Applied Earthworks, five are located within the Planning Area and are described by Applied Earthworks as the following:

The Northeast Central Hemet Historical Neighborhood: "This neighborhood is bounded by East Florida to the south and East Oakland Avenue to the north; this neighborhood does not include East Florida, however. The east/west boundaries are from North Santa Fe Street to North Buena Vista as well as the 100 block of North Juanita Street and block bounded to the north of Campus way and west of Weston Place (Horne and McDougal 2006)."

The Northwest Central Hemet Historical Neighborhood: "This neighborhood includes the Hemet Stock Farm and bounded to the north by East Oakland Avenue and to the south, but not including West Florida Avenue. The neighborhood is bounded to the east by North State Street and to the west by North Gilbert Street; it also includes the 100 block of Tahquitz and Las Lunas along its western boundary (Horne and McDougal 2006)."

The Southeast Central Hemet Historical Neighborhood: "This neighborhood is bounded on the north by East Florida. To the south, the neighborhood follows South Buena Vista Street south to Whittier Avenue; South Franklin, South Thompson, South Taylor Street to East Central Avenue; South Santa Fe south to Whittier Avenue and South San Jacinto, south past Mayberry to Olive Tree Lane, through the 500 block on the west side of the street, The eastern boundary of the neighborhood is along South San Jacinto Street, from Olive Tree Lane, north to Morton Place; the western Boundary is South Buena Vista past but not including South Juanita (Horne and McDougal 2006)."

The Southwest Central Hemet Historical Neighborhood: "This neighborhood is bounded by the corner of South Juanita Street and East Kimball Avenue, south to Whittier Avenue, west along Whittier Avenue to South Gilbert Street, north along South Gilbert Street to West Acacia, and continues north along the western block homes along South Ramona to West Kimball (Horne and McDougal 2006)."

The Hemet Downtown Historic Neighborhood: "This neighborhood includes all of North Harvard from the 100 block of South Harvard, north to the 300 block at the intersection with Meier Street and from the 100 block of West Florida Avenue to North Buena Vista cross-street on East Florida Avenue. This neighborhood also includes the city block bounded by East Latham to the north, North Carmelita to the east, East Florida Avenue to the south, and North Harvard to the west (Horne and McDougal 2006)."

Of the five neighborhoods identified by Applied Earthworks located within the Planning Area, four were confirmed to contain a higher density of historic-period or potentially historic-period structures than the surrounding areas. The neighborhoods confirmed by ECORP to include a higher density of resources than the surrounding area include:

- The Northeast Central Hemet Historical Neighborhood
- The Northwest Central Hemet Historic Neighborhood
- The Southeast Central Hemet Historical Neighborhood
- The Southwest Central Hemet Historical Neighborhood

The Downtown Hemet Historical Neighborhood has experienced wide-spread modern development in recent years, including the construction of the Hemet Public Library and the City of Hemet Police Station. This neighborhood was found to contain a mix of historic-period and modern structures but is primarily dominated by modern development. While the neighborhoods are not depicted on the Cultural Resources Overview and Sensitivity maps, the resources in these neighborhoods that ECORP has determined to be historic in age or potentially historic in age are provided in Figures 3 and 4 in Attachment A.


**Historic Map Review.** Historic maps were reviewed as part of this study. Available historic-period maps specific to the Planning Area include: the 1956 USGS 1:62500 Banning California topographic quadrangles (EIC); the 1901, 1905, 1913, 1925, 1929, 1937, 1942, 1950, 1952, 1955, 1960, 1963, 1964, 1971, and 1973 USGS 1:24000 topographic quadrangles (historicaerials.com); 1966, 1967 and 1972 aerial imagery (historicaerials.com); and the 1922 Sanborn Fire Insurance Maps (Los Angeles Public Library). A review of these maps was used to confirm suspected historic-age resources identified during the windshield survey and identify areas or neighborhoods of likely historic sensitivity. The results of the historic map review have been incorporated into the Cultural Resources Overview and Sensitivity Maps (Attachment A).

**The Hemet Heritage Foundation.** The Hemet Heritage Foundation is a non-profit organization dedicated to preserving and protecting the Hemet area's history and past. On January 11, 2017 ECORP submitted an inquiry via U.S. mail requesting any comment or input the Foundation may have regarding this study (Attachment C). As of the time of this report's submittal, the Foundation has not yet responded. Correspondence between the Hemet Heritage Foundation and ECORP after the submittal of this report will be forwarded to FCS and the City of Hemet.

**The City of Hemet General Plan and Final Environmental Impact Report (FEIR) Review.** ECORP reviewed the historic resources section of the City of Hemet's current General Plan and FEIR. As a result of the review, six Notable Local Historic Sites were identified within the Planning Area. Of the six resources indicated, one has since been demolished, the Hemet Grammar School. The Hemet Grammar School and surrounding area is currently undergoing active construction at the time of this report. Three of the six resources have been formally recorded: the Hemet Depot, the Hemet Grammar School (since demolished), and the Hemet Stock Farm. The Episcopal Church of the Good Shepherd was indicated on the HPDF but not formally recorded. All six of the City's Notable Local Resources have been incorporated into the list of Cultural Resources within the Planning Area (see Table 2a in Attachment B) and are indicated on Cultural Resources Overview Map (see Figure 3 in Attachment A).

## DATA COMPILATION AND FIELD VISIT

After completing the literature review described above, an ECORP Cultural Resources Specialist cross trained in Geographic Information Systems (GIS), Andrew Myers, used the records search results to identify parcels within the Planning Area that contain previously-recorded resources and then added that information into a database and a Cultural Resources Overview Map of the Planning Area. Resources listed on the HPDF were then added to the database and map to identify parcels with historic-age resources that have not been formally recorded but are listed in the HPDF. The Planning Area was found to contain a total of 77 known resources. Of the 77 identified resources, 29 were formally recorded, while 48 were indicated on the HPDF but not formally recorded. Publicly available Riverside County parcel data was then analyzed to identify parcels that contain structures with build dates prior to 1972. Parcels noted by the County Assessor's Office to contain structures built prior to 1972 were added to the Cultural Resources Overview Map (see Figure 3 in Attachment A).

After areas containing a high or low density of historic-period resources were identified, Mr. Myers and ECORP's Historic Resources Specialist, Kristina Lindgren, conducted a windshield survey to visually confirm previously-identified resources, to confirm parcel-

data build-dates, to observe vacant parcels, and visually identify potentially historic-period structures not previously recorded or indicated by the County Assessor. Identification of historic-period resources was determined by visual elements and style only. As a result, an additional 111 potentially historic-age resources were identified that have not been previously recorded, as well as eight previously-recorded resources that have since been demolished or built over. The results of the windshield survey have been incorporated into the list of cultural resources in Table 2a of Attachment B and are indicated on the Cultural Resources Overview Map (see Figure 3 in Attachment A). In total, the Planning Area was found to contain 188 historic or potentially historic-period resources.

Vacant parcels were identified using publically available County of Riverside Office of the Assessor parcel data and aerial photographs. Vacant lots indicated by county parcel data were observed during the windshield survey to confirm the status as vacant.

### **CULTURAL RESOURCES SENSITIVITY MAP METHODS AND RESULTS**

Cultural Resources Sensitivity Maps for historic resources and archaeological resources were produced by compiling information synthesized from the records search and literature review, publically available Riverside County Office of the Assessor parcel data, and the field visit. The Historic Resources Sensitivity Map indicates which parcels within the Planning Area have a low, moderate, or high potential to contain historic-age structures or features (i.e., elements of the built environment). Parcels identified as containing known historic-age resources or districts are indicated as high potential. Parcels with County Assessor data indicating the presence of a structure built prior to 1972, but have not been subject to formal survey or identification, were assigned moderate potential. Vacant lots and parcels identified as containing modern-age structures were assigned low potential for historic resources. The Historic Resources Sensitivity Map is provided as Figure 4 in Attachment A.

The Archaeological Sensitivity Map indicates the potential for each vacant parcel within the Planning Area to contain subsurface archaeological materials of either prehistoric or historic age. Due to extensive development within the Planning Area, assessment of archaeologically sensitive areas focused on parcels that have not been previously developed (i.e., vacant lots). Parcels containing structures or features, including parking lots, of either historic or modern age, were assigned a low potential to contain intact buried archaeological materials due to the extent of previous disturbance within those parcels. A total of 62 lots were confirmed as vacant within the Planning Area. All vacant lots within the Planning Area have experienced some level of grading or disturbance and are considered areas of moderate archaeological sensitivity as they may contain intact buried archaeological materials or either prehistoric or historic age. The historic-age railroad line that crosses the Planning Area was also assigned moderate sensitivity due to its potential to contain historic-age refuse and materials associated with construction and use of the railroad. No parcels or areas in the Planning Area display high archaeological sensitivity. The Archaeological Sensitivity Map is provided as Figure 5 in Attachment A.

## **MANAGEMENT SUMMARY**

A cultural resources review was conducted for the City of Hemet's Specific Plan for the historic core of downtown Hemet, Riverside County, California. As part of the study, information from several sources on previous cultural studies and known cultural resources was examined to produce a Cultural Resources Overview Map and Historic Resources and Archaeological Resources sensitivity maps for the City of Hemet's Downtown Planning Area. A total of 188 historic-age or potentially-historic-age resources were identified in the Planning Area. This total number of resources includes previously-recorded resources, resources identified as notable by the City of Hemet, and resources identified during a windshield survey of the Planning Area. Much of the Planning Area is designated as having a moderate to high potential to contain Historic Resources (i.e., elements of the built environment of historic age).

There are no known prehistoric resources located within the Planning Area and the prehistoric sensitivity of the Planning Area is generally considered low. Subsurface prehistoric resources are unlikely to exist within developed parcels. Vacant parcels, however, have some potential to contain buried prehistoric resources. Vacant parcels and the railroad alignment also have potential to contain surface or buried historic archaeological materials and, therefore, are assigned a moderate potential for archaeological resources. No parcels within the Planning Area are designated as having a high potential for archaeological resources.

Prior to development within the Planning Area, it is recommended that the Cultural Resources Overview and Sensitivity Maps, provided in Attachment A, be consulted to determine the sensitivity of the parcel to contain historic and archaeological resources. If the parcel is designated as having a moderate to high potential for Historic Resources, a project-specific cultural resources investigation shall be conducted by a qualified architectural historian or historic resources specialist to document and evaluate any extant historic-age structures or features for eligibility to the CRHR. If determined eligible, impacts to the resource from the proposed project shall be assessed in compliance with the California Environmental Quality Act (CEQA), with mitigation or avoidance measures developed for any significant impacts. Because this study did not include intensive field survey of each parcel within the Planning Area, if a parcel proposed for development is designated as having low potential for historic resources, efforts shall be made by a qualified archaeologist or architectural historian to confirm that there are no historic-age resources on the parcel.

If a parcel proposed for development is indicated as having a moderate potential for archaeological resources, field survey of the parcel by a qualified archaeologist shall be conducted to determine if there is any surface evidence of either prehistoric or historic-age archaeological materials. The survey shall also re-assess the potential of the individual parcel to contain buried resources based on the results of the field survey and the proposed depth of excavation. If determined to have moderate to high archaeological sensitivity, monitoring of ground-disturbing construction activities may be appropriate. In the event that new archaeological resources are identified during either survey or monitoring, they shall be recorded and evaluated for CRHR eligibility. If determined eligible, impacts to the resource from the proposed project shall be assessed in compliance with CEQA, with mitigation or avoidance measures developed for any significant impacts.

If human remains of any kind are found during development, the requirements of CEQA Guidelines Section 15064.5(e) and AB 2641 shall be followed. According to these requirements, all construction activities must cease immediately and the Riverside County Coroner and a qualified archaeologist must be notified. The Coroner will examine the remains and determine the next appropriate action based on his or her findings. If the coroner determines the remains to be of Native American origin, he or she will notify the NAHC. The NAHC will then identify the most likely descendants (MLD) to be consulted regarding treatment and/or reburial of the remains. If an MLD cannot be identified, or the MLD fails to make a recommendation regarding the treatment of the remains within 48 hours after gaining access to the remains, the property owner shall rebury the Native American human remains and associated grave goods with appropriate dignity on the property in a location not subject to further subsurface disturbance.







This project location is in proximity to known sites, is a shared use area that was used in ongoing trade between the tribes, and is considered to be culturally sensitive by the people of Soboba.

Soboba Band of Luiseño Indians is requesting the following:

1. **Government to Government** consultation in accordance to SB18. Including the transfer of information to the Soboba Band of Luiseño Indians regarding the progress of this project should be done as soon as new developments occur.
2. Soboba Band of Luiseño Indians continue to be a consulting tribal entity for this project.
3. Working in and around traditional use areas intensifies the possibility of encountering cultural resources during the construction/excavation phase. For this reason, the Soboba Band of Luiseño Indians requests that Native American Monitor(s) from the Soboba Band of Luiseño Indians Cultural Resource Department to be present during any ground disturbing proceedings. Including surveys and archaeological testing.
4. Request that proper procedures be taken and requests of the tribe be honored (Please see the attachment)

**Cultural Items (Artifacts).** Ceremonial items and items of cultural patrimony reflect traditional religious beliefs and practices of the Soboba Band. The Developer should agree to return all Native American ceremonial items and items of cultural patrimony that may be found on the project site to the Soboba Band for appropriate treatment. In addition, the Soboba Band requests the return of all other cultural items (artifacts) that are recovered during the course of archaeological investigations. Where appropriate and agreed upon in advance, Developer's archeologist may conduct analyses of certain artifact classes if required by CEQA, Section 106 of NHPA, the mitigation measures or conditions of approval for the Project. This may include but is not limited or restricted to include shell, bone, ceramic, stone or other artifacts.

The Developer should waive any and all claims to ownership of Native American ceremonial and cultural artifacts that may be found on the Project site. Upon completion of authorized and mandatory archeological analysis, the Developer should return said artifacts to the Soboba Band within a reasonable time period agreed to by the Parties and not to exceed (30) days from the initial recovery of the items.

**Treatment and Disposition of Remains**

A. The Soboba Band shall be allowed, under California Public Resources Code § 5097.98 (a), to (1) inspect the site of the discovery and (2) make determinations as to how the human remains and grave goods shall be treated and disposed of with appropriate dignity.

B. The Soboba Band, as MLD, shall complete its inspection within twenty-four (24) hours of receiving notification from either the Developer or the NAHC, as required by California Public Resources Code § 5097.98 (a). The Parties agree to discuss in good faith what constitutes "appropriate dignity" as that term is used in the applicable statutes.

C. Reburial of human remains shall be accomplished in compliance with the California Public Resources Code § 5097.98 (a) and (b). The Soboba Band, as the MLD in consultation with the Developer, shall make the final discretionary determination regarding the appropriate disposition and treatment of human remains.

D. All parties are aware that the Soboba Band may wish to rebury the human remains and associated ceremonial and cultural items (artifacts) on or near, the site of their discovery, in an area that shall not be subject to future subsurface disturbances. The Developer should accommodate on-site reburial in a location mutually agreed upon by the Parties.

E. The term "human remains" encompasses more than human bones because the Soboba Band's traditions periodically necessitated the ceremonial burning of human remains. Grave goods are those artifacts associated with any human remains. These items, and other funerary remnants and their ashes are to be treated in the same manner as human bone fragments or bones that remain intact

**Coordination with County Coroner's Office.** The Lead Agencies and the Developer should immediately contact both the Coroner and the Soboba Band in the event that any human remains are discovered during implementation of the Project. If the Coroner recognizes the human remains to be those of a Native American, or has reason to believe that they are those of a Native American, the Coroner shall ensure that notification is provided to the NAHC within twenty-four (24) hours of the determination, as required by California Health and Safety Code § 7050.5 (c).

**Non-Disclosure of Location Reburials.** It is understood by all parties that unless otherwise required by law, the site of any reburial of Native American human remains or cultural artifacts shall not be disclosed and shall not be governed by public disclosure requirements of the California Public Records Act. The Coroner, parties, and Lead Agencies, will be asked to withhold public disclosure information related to such reburial, pursuant to the specific exemption set forth in California Government Code § 6254 (r).

Ceremonial items and items of cultural patrimony reflect traditional religious beliefs and practices of the Soboba Band. The Developer agrees to return all Native American ceremonial items and items of cultural patrimony that may be found on the project site to the Soboba Band for appropriate treatment. In addition, the Soboba Band requests the return of all other cultural items (artifacts) that are recovered during the course of archaeological investigations. Where appropriate and agreed upon in advance, Developer's archeologist may conduct analyses of certain artifact classes if required by CEQA, Section 106 of NHPA, the mitigation measures or conditions of approval for the Project. This may include but is not limited or restricted to include shell, bone, ceramic, stone or other artifacts.

**Confidentiality:** The entirety of the contents of this letter shall remain confidential between Soboba and the City of Hemet. No part of the contents of this letter may be shared, copied, or utilized in any way with any other individual, entity, municipality, or tribe, whatsoever, without the expressed written permission of the Soboba Band of Luiseño Indians.
