**A RESOLUTION OF THE CITY COUNCIL OF THE CITY  
OF HEMET, CALIFORNIA, ADOPTING A POLICY FOR  
THE DISTRIBUTION OF EVENT TICKETS AND PASSES  
TO CITY OFFICIALS**

The City Council of the City of Hemet, California (hereafter referred to as the "City Council") does resolve as follows:

**WHEREAS**, from time to time, the City of Hemet (the "City") receives event tickets and passes from third party sources, or obtains them directly, for use by various City officials; and

**WHEREAS**, from time to time, City officials are offered tickets and passes from third party sources for personal use; and

**WHEREAS**, pursuant to section 18944.1 of Title 2 of the California Code of Regulations ("Regulations"), such tickets and passes are defined as those that provide admission to a facility, event, show or performance for an entertainment, amusement, recreational or other similar purpose; and

**WHEREAS**, the City desires to use and distribute such tickets and passes to further governmental and public purposes, such as the promotion of City businesses, resources, programs and facilities; and

**WHEREAS**, the City also desires to clarify the rules and regulations related to City officials' receipt of tickets and passes from third party sources for personal use; and

1           **WHEREAS**, tickets and passes are not considered gifts to public officials if the  
2 City distributes the tickets and passes in accordance with a duly adopted written policy  
3 consistent with the provisions of section 18944.1; and

4           **WHEREAS**, the attached policy must be maintained as a public record, is  
5 subject to inspection and copying under section 81008, and shall be posted on the  
6 City's website within (30) days of adoption and sent to the Fair Political Practices  
7 Commission ("FPPC").

9           **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HEMET FINDS,**  
10 **DETERMINES, ORDERS AND RESOLVES AS FOLLOWS:**

11           **SECTION 1.** The above recitals are all true and correct.

12           **SECTION 2.** The City Council hereby adopts the "Ticket Policy" attached hereto  
13 as Exhibit "A."

15           **SECTION 3.** The City Manager, or his designee, is hereby authorized to take  
16 any actions necessary to implement this policy, including posting the policy on the  
17 City's website within thirty (30) days of adoption and sending a copy of the policy to the  
18 FPPC.

19           **SECTION 4.** This Resolution shall take effect upon its adoption.


